TIPS ABOUT HOW TO NOMINATE A COLLEAGUE

- 1. Q. Who can be nominated?
 - A. Anyone who is a nurse.
- 2. Q. What is the best format to select? I want to be certain my nominee has the best possible chance of winning an award.
- A. Read over all 3 awards carefully and decide which award best suits your nominee.

Be certain you clearly indicate which award you are nominating your candidate for when you make your submission.

Using the template that is proved, develop clear, concise <u>examples</u> of specific situations, which describe the four specific criteria listed beneath the award.

- 3. Q. Does it make a difference if a nominee has several people nominating them? Are they any more likely to receive an award?
- A. No. The person most likely to receive an award is the one who most completely meets the outlined criteria. It is not the quantity of signatures, but the quality of the examples.
- 4. Q. Do I need to be a great writer to nominate someone?
- A. No, but you do need to give specific examples which give the reviewers a clear vision of exactly how excellent your nominee is.
- 5. O. How is a successful candidate chosen?
- A. All submissions must be received by the date announced each year, usually near the end of April. Corporate Nursing Team Assistant will prepare all applications for the blind review process and will be the only person who sees the nominations prior to the review process. This means that she will remove all identifying information (i.e. name). The submissions are forwarded to the Review Committee who will rank the submissions according to the criteria outlined.
- 6. Q. When and where are the awards presented?
- A. Once the Committee has made their selections, the award winners will be notified during Nursing Week each year. The awards will be presented on Tuesday in June at the Excellence in Nursing Awards ceremony.
