Delineation of Procedural Privileges

Department of Paediatrics

Only members of the Division of Neonatal/Perinatal Medicine within the UWO Department of Paediatrics may work and admit patients to the Neonatal Intensive Care Unit. Patient admission to the Paediatric Critical Care Unit requires consultation with the PCCU attending physician.

The Royal College of Physicians and Surgeons of Canada (RCPSC) have provided Canadian specialty certification in Paediatric Critical Care Medicine since spring of 2006. Between the fall of 1990 and 2006, individuals were recognized who had successfully completed training in a RCPSC accredited program (accreditation without certification).

All Professional Staff providing coverage in a level 3 Paediatric Critical Care Unit (as defined by the Critical Care Secretariat, MHLTC) will either have their primary appointment in the Department of Paediatrics, Division of Paediatric Critical Care Medicine; or their primary appointment in their base specialty with a cross appointment to the Department of Paediatrics Division of Critical Care Medicine. The following delineations will be applied to all appointments providing coverage in a level 3 Critical Care Unit.

Category	Privileges	Educational/Experience Requirements
A	All activities and procedures generally performed by those physicians trained and/or certified in Paediatrics.	Specialty Certification from the Royal College of Physicians and Surgeons of Ontario, or an Academic Certificate from the College of Physicians and Surgeons of Ontario. Specialty Certification from the Royal College of Physicians and Surgeons of Canada in Paediatric Critical Care (if training completed after 2006) or appropriate core specialty with evidence of successful completion of RCPSC accredited program if training completed between 1990 and 2006, or an Academic Certificate from the College of Physicians and Surgeons of Ontario. OR Privileges granted to physicians not certified in the specialty of Paediatric Critical Care Medicine, but who have experience, training and demonstrated competence. Equivalent training as assessed and supported by the Chief of the Department.
