



Delineation of Procedural Privileges Department of – Medicine

All members of the Department of Medicine must have their fellowship in Internal Medicine, and training in the appropriate subspecialty. Members of other departments are given cross appointments in internal medicine when the interests of such individuals coincide or overlap with those of the Department of Medicine and when they provide special expertise to the department. Such individuals must have the qualifications required for membership in their primary department.

Division of Critical Care Medicine

The Royal College of Physicians and Surgeons of Canada (RCPSC) have provided Canadian specialty certification in Critical Care Medicine since spring of 2006. Between the fall of 1990 and 2006, individuals were recognized who had successfully completed training in a RCPSC accredited program (accreditation without certification).

All Professional Staff providing coverage in a level 3 Critical Care Unit (as defined by the Critical Care Secretariat, MHLTC) will either have their primary appointment in the Department of Medicine, Division of Critical Care Medicine; or their primary appointment in their base speciality with a cross appointment to the Department of Medicine, Division of Critical Care Medicine. The following delineations will be applied to all appointments providing coverage in a level 3 Critical Care Unit.
