B-FM	<p>Privileges requiring specialized training, including:</p> <ol style="list-style-type: none"> 1. Acupuncture 2. Excise skin carcinoma 3. Skin grafting 4. Remove entire toenail 5. Remove corneal rust ring 6. Place posterior nasal packing 7. Needle thoracentesis 8. Insert chest tube 9. Gastric lavage 10. Paracentesis 11. Flexible sigmoidoscopy and biopsy 12. Vasectomy 13. Conduct spontaneous labour and birth, postpartum care and uncomplicated repairs to perineal tears within the scope of their training and accepted practice. 2. The ability to assist with the birth of an infant safely from the anterior occiput position in the low pelvic station spontaneously, or using outlet forceps or vacuum extraction. 3. The ability to manage an uncomplicated third stage labour and to recognize complications, the implication of abnormalities during labour and postpartum care of the woman. This will include uncomplicated tears or episiotomies. 4. Manual removal of the placenta. 5. Augmentation of labour when there has been poor progress and/or irregular contraction pattern. 6. Induction for pregnancies >41 weeks and <42 week, or, >37 weeks with PROM, and no labour, and low risk. For pregnancies requiring induction that are outside these limits family physicians should consider obstetrical consultation. 7. The use of bedside Ultrasound to assess fetal and placental position. 8. Pregnancy induced hypertension. 9. Antepartum hemorrhage. 10. Medical complications that potentially threaten the outcome of the pregnancy (diabetes, heart disease, renal disease, 	<p>Certification from the College of Family Physicians of Canada.</p> <p>Letter of recommendation from the Chief of Family Medicine, including the need for five deliveries, supervised by one or more of the family physician obstetricians.</p> <p>The requirement for supervised deliveries may be waived by the Chief of Family Medicine, if evidence of satisfactory training (PGY3 program) or experience is provided.</p> <p><u>PROCEDURES 8-10</u> Family physicians should consider consultation with an obstetrician.</p>
