

Table Top Fire Drill Report Form

Table talk fire drills provide opportunities to assess adequacy of the emergency preparedness of persons on all shifts and in individual tenancies, as well as departments or area-specific responses. They may help identify local risks or hazards and the need to update procedures and practices. No fire alarm systems are to activated during a table talk drill. The fire drill outcomes are documented and where concerns are identified, corrective measures are implemented. In some instances, after the table talk discussion a silent drill or comprehensive drill could be initiated to reinforce appropriate responses by staff and occupants.

This form should be completed by the Emergency Management and Risk Specialist, a Department Head, Manager, Director, Coordinator or a delegate.

An attendance form should also be completed to capture the names of the staff that participated in the table talk drill.

Provide the following questions in **bold** lettering to the staff. Circle Yes or No based on the staff response. Indicate **NO** if staff miss any of the steps related to each question. If a step is missed provide staff with the correct guidance and information.
